# WHAT DOES UIF CORPORATION DO WITH YOUR PERSONAL INFORMATION?

### Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

### What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security Number and Income
- Transaction History and Credit History
- Credit Scores and Employment Information
- Contact Information (e.g., name, sex, age, date of birth, email address, mailing address, telephone number, driver's license, passport, and/or other government issued ID numbers)

When you are no longer our customer, we continue to share your information as described in this notice.

How?

Non-affiliates	Companies not related by common ownership or control. They can be financial and non-financial companies.	
	Non-affiliates we share with can include financial services companies such as LPL Financial, LLC, Credit Union Trust, and others as well as non-financial companies.	
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.
